Member Presentation(s):

David Ude & Lynn Benson with Rehabilitation Hospital of Montana

- They are a **<u>REHABILITATION</u>** hospital only.
 - There are no acute care capabilities.
- Most patients average 10-12 days in the facility.
- This is a state-of-the-art facility that focuses on strength building, cooking, balance, etc.
- Most of their patients are victims of stroke or spinal cord damage/injuries.
- The facility does have a 400KWH generator that they currently only use 20% of, though it is not portable.

Clark Snyder with RiverStone Health – Environmental Health Services (County Sanitarian)

- 12 staff:
 - o 8 Sanitarians
 - o 2 Managers
 - o 2 Administrative Assistants
- They serve 1100 food establishments currently licensed in Yellowstone County.
- Montana Department of Environmental Quality (DEQ) contracts with this department to oversee and inspect septic permitting.
- There are DEQ air quality monitoring sites at the RSH building. These monitor particulate matter from fires, refinery outputs, etc.
- In 2023, RSH-EHS:
 - Conducted over 3000 inspections of licensed facilities and septic permits.
 - Investigated over 300 complaints
- RSH-EHS also reviews plans for new businesses (especially for food)

Member Presentation(s) continued:

Clark Snyder with RSH-EHS (County Sanitarian) (continued)

- Question: Do you have actual places where emergency shelters can be set up or simply help with setup and layout?
 - RiverStone Health does not have the facilities/access to locations, but YC DES has shelter location MOUs in place or has pre-identified several locations for temporary emergency sheltering. Red Cross can support with volunteers and shelter supplies and shelter setup.
 - MetraPark has been used previously for sheltering needs as needs arise.
 - MSUB was previously used for a large sheltering operation during the Lame Deer Fires.
 - Coordinate with Taylor Slabaugh at HRDC for sheltering and childcare support.

Subcommittee Reports:

- Citizen Corps Council (CCC) / (CAER)
 - \circ Meets the 4th Tuesday of every month @ 0900 at United Way.
 - Current effort is to get more information on emergency preparedness to families through their kids.
 - Billings Public Schools (BPS) is partnering with Billings Fire to pilot at eight elementary schools this year to expand to more schools next year
 - CCC is shifting efforts to reduce duplication of effort
 - Also working with Red Cross and their Ready Rating for businesses and working on promotional material for HAZMAT in the home awareness efforts.
- Communications
 - Did not meet No report.
- Conference
 - Did not meet No report.
- Crisis Communications
 - Did not meet No report.
- Exercise Design
 - Meets the 4th Tuesday of every month @ 1030 (United Way or Virtual).
 - o Old Business:
 - Improvement plans that result from exercises and actual events.
 - We have not had much real-world application to see if and how the improvements have been implemented.
 - Hospital notifications need to have a follow-up exercise to test the notifications process and ensure that hospitals are actually notified through the lamResponding (IAR) system.
 - Mass fatality protocols in new CAD system will trigger automatic notification through IAR to hospitals.
 - Dispatch ran a test run through IAR and was successful in notifying the correct people. However we have not had a real incident since to further test the process.
 - Hospital family reunification process/plans need to work with the airport/airlines to align the process and meet federal requirements.
 - By-laws review is on hold until new subcommittees are finalized.
 - BPS to carry out a 3-day training exercise with the Rescue Task Force (RTF) and Billings Fire at West High School on July 31 from 0800-1800.
 - They are working to get 50-75 parent and student volunteers to run a family reunification exercise. Using the I Love You Guys reunification model (from 1200-1400).
 - It will be an armed intruder scenario and they are looking for additional volunteers.
 - Currently working to encourage staff members to participate in the exercise.

- Reach out to Joe Halligan if you want to observe, participate, be a role player, etc.
- Currently working with school administrative staff to clarify expectations and reality.
- Hospital Traffic Corridor Plan for construction is tabled until the next meeting so stakeholders have an opportunity to meet.
- BBWA Ditch Breach Preparedness has been tabled. The County does have a breach pre-plan that was completed in 2023. BBWA received several grants to update and mitigate concerns.
 - There is currently no need to exercise this plan as we've had 2 real events in the past five years and the area is being actively monitored.
 - Once new infrastructure pieces are in place (waiting for grant funding to be approved and projects completed) we should review the plan and test to see how these new pieces play into the equation.
- RiverStone Health is conducting an internal Measles TTX on May 14.
- FAA mandated airport TTX on May 23.
- New Business:
 - How to get information about the LEPC out to the public?
 - New public education committee
 - Cyberattack exercise at MSUB took place 2 months ago and was run by CISA.
- City and County leadership requested a continuity of operations plan following the G0402 class in October 2023.
 - DES partnered with EPA and TetraTech to develop the exercise.
 - Final planning meeting was on May 7th.
 - TTX on June 5th for elected officials and responders.
- Grants
 - Hazard Mitigation Grant Program (open to local governments) to address future losses/future mitigation is now available.
 - Volunteer Fire Capacity (VFC) Grant has closed. YC-DES on behalf of the Rural Fire Council submitted an application with a total funding request of \$57,847.35.
 - The Assistance to Firefighters grant application period has closed.
- Planning
 - Currently working on the Emergency Operations Plan (EOP).
 - The structure and outline for the Base Plan is done and was sent out to the Planning Subcommittee for review.
 - Decided content is good, final formatting in progress.
 - \circ $\;$ The Crisis Communications Plan is slated for review and updates in June.
 - The Multi-Hazard Mitigation Plan (MHMP) has been sent into the state and FEMA. Awaiting feedback/response.
 - Also working on a small traffic control plan for MetraPark for large events to help clear the parking lots faster/more efficiently.
 - Work on the MetraPark Evacuation Plan is also underway.

- Training
 - As there is no chair, there are no meetings.

Continuing Discussion/Old Business:

- Meeting of the new subcommittee chairs is set for the end of May. New chairs will be provided with subcommittee chair guidebooks on what needs to be done as a chair and how to capitalize on the soft match potential.
 - Subcommittee report outs will start to look a little different starting in June/July.
 - More HAZMAT content will be reported out.
- Hazardous Release Report
 - DEQ sent out a few letters of completed work and approved mediation.
 - 2 letters sent to agencies that need work.
 - All other calls were small spills, flaring, etc.

PUBLIC COMMENT:

- KC Williams Yellowstone County DES:
 - \circ I will be leaving for vacation starting this afternoon (5/8) through 5/20.
- Nick Vertz National Weather Service (NWS):
 - NWS does spot weather forecasts for wildfires, floods, prescribed fires, etc.

- New request website set to go public end of June/beginning of July.
- \circ $\,$ More details to follow.
- Don Jones Yellowstone County Commissioner:
 - Discussing temporary morgues given the morgue shortage during COVID.
 - Do we have enough capacity?
 - The State has a portable morgue with 25 additional capacity.
 - The one that Harry Schlitz with HOPE K9 Dogs saw at the South Dakota conference took about 30 minutes to setup and could hold up to 12 additional capacity.

TOPICS OF NOTE/SITUATIONAL AWARENESS:

- YC-DES:
 - DHS/CISA continue to send out notifications of civil unrest threats and hazards directed at government facilities, school, colleges, etc.
 - Smaller places like Billings are just as susceptible as the 'big' cities.
- HOPE K9:
 - Team attended the Mass Casualty Conference in South Dakota last week. Interesting content (emergency shelters, temporary morgues, etc.).
- Billings Airport:
 - Ron Smith is the new head of ARFF (the new Paul)
 - Paul Totton's new role at the airport is to support and create compliance documentation and requirements as per federal requirements.
 - He is currently acting as a temporary employee/consultant until permanent compliance officer is hired.
