Resolution No. 24-98

Resolution to Dissolve Yellowstone County Rural Special Improvement District No. 713M (Tanglewood Lake Estates Subdivision 2nd Filing)

WHEREAS, pursuant to Sections 7-12-2124 of the Montana Code Annotated, a board of county commissioners has the authority to dissolve a rural special improvement district. To dissolve a district a board of county commissioners passes a resolution of intent to dissolve the district, sets a public hearing on the dissolution, mails notice of the public hearing to the landowners in the district, publishes notice of the public hearing, receives protests on the dissolution, receives comments on the dissolution, holds a public hearing, considers the protests and comments and passes a resolution to dissolve the district. A board of county commissioners can only dissolve a district if it would be in the best interest of the public, the district can pay its debts and enough landowners have not protested the dissolution.

WHEREAS, the Yellowstone County Board of County Commissioners created Yellowstone County Rural Special Improvement District No. 713M to maintain roads within the District. Since RSID 713M Tanglewood Lake Estates Subdivision 2nd Filing is encompassed within RSID 715M Tanglewood Lake Estates Subdivision, RSID 713M will be dissolved and the parcels will be added to RSID 715M. Attached as Exhibit A is a map showing the RSID to be dissolved and Exhibit B showing the property listing of the parcels within the RSID to be dissolved.

WHEREAS, on April 30, 2024, the Yellowstone County Board of County Commissioners passed a resolution of intent to dissolve Yellowstone County Rural Special Improvement District No. 713M and set a public hearing on the dissolution for June 11, 2024. On May 3, 2024 and May 10, 2024, the Yellowstone County Clerk and Recorder published notice of the public hearing. On May 3, 2024, the Clerk and Recorder mailed notice of the public hearing to the landowners in the District. On June 11, 2024, the Board held a public hearing on the dissolution. The Board determined it would be in the best interest of the public to dissolve the District and add those parcels to RSID 715M. Funds in RSID 713M will be transferred to RSID 715M for ongoing road maintenance. Not enough landowners protested the dissolution of the District.

NOW THEREFORE, BE IT RESOLVED,

The Yellowstone County Board of County Commissioners dissolves Yellowstone County Rural Special Improvement District No. 713M. The District is encompassed by RSID 715M and the parcels will be added to RSID 715M. The Board orders the Yellowstone County Clerk and Recorder to mail notice of the resolution to the landowners in the District. The Board orders the Yellowstone County Finance Department to pay the debts of the District and to transfer any remaining funds to RSID 715M.
